The following items must be submitted electronically on the City of Savage website or dropped off at City Hall.

The Planning Department is available to help with the submittal items including the site plan drawing. An existing site plan may be on file at the City that can be used for your submittal. Please contact the Planning Department at 952-882-2650 for assistance.

#### Submittal Items:

- 1. Application form filled out completely.
- 2. Drawing of site to scale showing the following:
  - Location and dimensions of entire expansion area
  - Location of existing building with entrances and exits shown
  - Location and dimension of tents and any other temporary structures with exits shown
  - Location of water and electrical hookups
  - Scale of drawing and north arrow
  - Location of all parking stalls and depict all stalls utilized for temporary expansion area please clearly identify number of stalls that remain available for customer parking
  - Traffic management (fencing, barricades) materials and placement
  - Any other important features
- 3. Floor plan diagram of expansion area showing the following:
  - Location of exits
  - Location of fire extinguishers
  - Location of tables, chairs and walkway
  - Food and beverage stations and cooking stations
  - If serving liquor, clearly identify where liquor will be served
  - Any other important features
- 4. If tent is larger than 120 square feet, the following is required:
  - Prior to acquiring tent, contact Fire/Building Inspections Departments regarding wind and fire rating regulations
  - Tent drawing showing dimensions (height & width)
  - Indicate type of tent material and include Certificate of Flame Resistance
  - Provide details on tent anchoring
- **5.** For restaurants with liquor licenses that will serve liquor in expansion area, a Certificate of Liability Insurance covering the expansion area must be submitted.
