RESIDENTIAL BUILDING (Plan Review Required)

Permit fees are based on the value of the project and include the permit fee, plan review fee, state surcharge fee, and a technology fee. Additional fees may also apply. Below is a list of common residential projects that are calculated based on a minimum valuation of the work. Permit fees may vary if the scope of work is higher than the minimum valuations listed. Plumbing/mechanical fees (\$65.00) are included in the building permit fees where applicable. If you do not see your project on the list below, please contact the Building Inspections Department for an estimate.

SEWER AVAILABILITY CHARGE (SAC)

If your permit involves a new business, a business changing locations, or altering a commercial space, you will be required to submit for a sewer availability charge (SAC) determination through Metropolitan Council at metro council.org/SACsubmittal. Your project may incur SAC fees as determined by MetCouncil. Total SAC charges are based on the number of SAC Units due. For example, if MetCouncil determines three SAC Units are due, the fees listed below would be multiplied by three. Additional fees may apply such as meter fees, inspection fees, and irrigation impact fees where applicable. Most new residential construction projects are charged one SAC Unit per dwelling. Please reference the Sewer Availability Charge (SAC) fees listed in the table below.

COMMERCIAL BUILDING (Plan Review Required)

Permit fees are based on the value of the project and include a permit fee, plan review fee, state surcharge fee, and a technology fee. Additional fees may also apply. Please contact the Building Inspections Department if you need an estimate of the permit fees that may be included in the cost of your permit.

COMMERCIAL MECHANICAL AND PLUMBING (Plan Review Required)

Commercial Mechanical Permit fee is 2% of Valuation Plus State Surcharge and \$5 Technology Fee	Permit Fee Formula (Valuation x .02) + (Valuation x .0005) + 5 *Minimum Permit Fee \$155
Commercial Plumbing Permit fee is 2% of Valuation Plus State Surcharge and \$5 Technology Fee	Permit Fee Formula (Valuation x .02) + (Valuation x .0005) + 5 *Minimum Permit Fee \$155

DEMOLITION PERMITS (Not Available Online)

Demolition permit fees are for the demolition of an entire building/structure

Building (Dwelling or Commercial/Industrial Building)	\$100 Permit Fee Per Building + \$5,000 Deposit
Accessory Building/Structure	\$50 Permit Fee Per Accessory Building + \$2,000 Deposit

Technology Fee	\$5.00
Re-inspection Fee	\$63.25 per hour
Additional Plan Review Fee (For changes, additions or revisions to approved plans)	\$63.25 per hour (Minimum charge of one-half hour = \$31.63)
