

## **Let's Talk Trash!**



Specifically, where to store your trash and recycling containers. The current ordinance was put in place in 2012 and states, "Trash and/or recycling bins must be located out of public view except on collection day." The phrase "out of public view" can be interpreted in many ways. Does it mean not visible from the public street? Or perhaps, not visible from a neighboring property? Recently we

collected data from over 2,000 residential properties, in 19 different neighborhoods, from all areas of the City on where residents are currently storing their refuse containers. We found that over half of the properties had containers in public view from the street and would be in violation of the current ordinance. So, the City is reviewing the ordinance to determine if it needs to be changed or just made more clear. But before any changes are made, we want to hear your opinions and ideas on where you want trash and recycling bins stored. Share your opinions and input now through March 12 at letstalksavage.com.

## **Building Permits:** What you need to know.

#### Do you have an open permit?

Whenever homeowners or contractors apply for a permit, the permit issued for that work is considered "open" and stays open until all required inspections have been completed and approved. Typically when the work is completed, a final inspection is approved, and the permit is "closed" with the City. Failure to close a permit implies that the City Building Inspections Department has not approved construction, and it is unknown if the work performed is code compliant. This can result in construction-related issues, refinancing problems, and issues with future home sales. To find out if you have any "open" permits on your property, go to epermits.logis.org, select Savage as the participating City you want to search for, then select Search for Permit. You can search by address for any permits that were issued recently. If you find a permit that does not have a "Final Date," the permit may still be open or expired. Contact the contractor or permit applicant to schedule an inspection with the City.

#### Any Spring projects planned?

Decks, driveways, fences, sheds, windows, porches, pools, garages - whatever your project is, get the information you need on acquiring the proper permits and plans rolling at cityofsavage.com/buildingpermits. Getting the proper permits and site plan approvals can take time, so consider starting the process ASAP if you'd like to start building this spring. The intent is to encourage residents to replant a diversity of tree species after a tree is lost to disease, EAB, or storms. Trees must be ordered and paid for online at **cityofsavage.com**; there is a limit of five trees per household. Trees are sold on a first-come, first-served basis until sold out or until April 14.

This sale is open to all Savage, Prior Lake, Credit River, and Spring Lake Township residents.

**Species Available:** Blue Beech, River Birch, Prairifire Crabapple, Purple Prince Crabapple, Snowdrift Crabapple, Valley Forge Elm, Ivory Silk Lilac Tree, Linden Boulevard, Green Mountain Sugar Maple, Heritage Oak, Swamp White Oak, White Pine, and Black Hills Spruce. Limited quantities; maximum of 5 per household.

## Savage Police add Coordinated Response Social Worker

In the past several years, law enforcement calls involving mental health crises have increased significantly. And while officers are trained in handling mental health emergencies, Savage Police will now have a new partner to help assist in these types of situations. The Scott County Coordinated Response Unit is a brand-new program and partnership between Scott County Human Services and the Sheriff's Department, Savage Police Department, and Shakopee Police Department. The program's objective is to use a social worker's skills and resources to help resolve mental health crises with adults, children, and families in the community and connect them to needed services before their needs escalate to deeper-end services.

#### How does it work?

As part of this program, a licensed social worker will be assigned to the Savage Police Department. When a responding officer has concerns about a community member, they will send a referral to the Coordinated Response social worker for follow-up. The social worker will review the information, decide on an intervention strategy, and determine if the individual could use follow-up contact to help advise on additional resources, support, and referrals for ongoing needs. Coordinated Response social workers can also respond to in-progress calls as needed and deemed appropriate.

This new mental health initiative is funded partly by funds from the 2022 Opioid Settlement and is expected to begin in March 2023.

The presentation includes personal stories, video clips, and an opportunity to ask questions. The IOOV program has touched many lives and is effective in reducing the misperceptions surrounding mental illness. No registration is required.

### **Reminders**

#### Pothole patching is in progress.

Winter can be tough on all of us, even our roads. Every time water gets into cracks and freezes, the crack will expand by almost 10%. So, the repeated freeze-thaw nature of winter and spring in Minnesota all but guarantees that potholes will form on roads. 
