Liability and Release Form for Batting Cages:

I hereby acknowledge and agree that participation in the batting cages within Savage Sport Center, has inherent risks. In consideration of the services provided by the City of Savage, their participants, employees and all persons or entities acting in any capacity on their behalf, I now agree and certify as follows:

1. I acknowledge and fully understand that I, _____, the participant (if participants is 18 years of age or older) or parent/legal guardian of the above listed minor participant, will be engaging in activities that may involve risk of serious injury or death which might result not only from my own actions, inactions, or negligence, but from the actions, inactions, or negligence of others over whom the City of Savage has no control, or the conditions of the premises or of any equipment used. Further, that there may be other risks not known or not reasonable foreseeable at this time. The risks may include, but are not limited to: nature of the activity, latent or apparent defects of conditions in equipment or property supplied by Savage Sport Center or other entity; acts of other participants in this activity, employees of Savage Sports Center; my own physical condition, acts of omissions; conditions of Savage Sports Center facility and surrounding grounds or terrain and accidents connected with their use; first aid emergency treatment or other services.
2. I expressly accept and assume all the risks existing in this activity, including bodily injury, death or property damage arising out of my participation. My participating in this activity is purely voluntary and I elect, in spite of the risks, to participate. I assume all the foregoing risks and accept personal responsibility for the damages following such injury.
3. On behalf of myself, my children, my parents, my heirs, assigns, and personal representative, I hereby voluntarily release, waive, forever discharge, and agree to indemnify and hold harmless the City of Savage, and each of their respective commissioners, directors, employees, its parent, subsidiaries, affiliates, other batting cage participants, and if applicable, operators or lessors of premises used to conduct the event/activity, from any and all liability for any and all claims, whether known or unknown, demands, or causes of action, which are in any way connected with my participation in this activity or my use of Savage Sports Center equipment or facilities.
4. I hereby certify that I am at least 18 years old, or the part or legal guardian of the participant under 18, and I or, as applicable, my minor child will wear a batting helmet at all times while in the batting cages. I hereby provide employees of the City of Savage, permission to administer basic first aid and I authorize employees of the City of Savage to contact 911 or other emergency personnel as needed.
5. I hereby certify that I have been given the Pitching Machine Cage Recommendations & Rules for batting cage use and will adhere to them.

By signing this document, I acknowledge that if anyone is hurt, or property is damaged during participation in this activity a court of law may find me to have waived my right to maintain a lawsuit against the City of Savage or its employees.
